Dear Ms. Halpin,

I refer to the request which you have made under the Freedom of Information Act 2014 for access to records held by this Department, as follows:

- *Transcripts of any complaints made to the Department of Foreign Affairs between 16 March 2019 and 20 March 2019 over the appearance of Conor McGregor at the St Patrick's Day parade in Chicago, US on 16 March.*
- *All correspondence made to the Department of Foreign Affairs mentioning Conor McGregor between 16 March 2019 and 20 March 2019.*
- *All internal correspondence made within the Department of Foreign Affairs between 16 March 2019 and 20 March 2019 regarding Conor McGregor and the Chicago St Patrick's Day parade on 16 March.*
- *All memos sent to/within the Department of Foreign Affairs between 16 March 2019 and 20 March 2019 regarding Conor McGregor and the Chicago St Patrick's Day parade on 16 March.*

I refer also to the acknowledgement of your request which was sent to you on 27th March 2019.

I have identified 1 record that falls within the scope of your request. The record is listed in the schedule attached and I have made a decision to part grant the release of this record.

Where access has been only partially released the case relates to section 37(1) Personal Information.

Section 37 – Personal information

While Section 37(1) Personal Information is a mandatory exemption I am still obliged to consider whether the public interest would be best served by releasing the records in full. I have taken into account the benefit to the public to be given access to correspondence in a manner which demonstrates transparency and accountability of the Department. The information redacted relates to personal contact information and does not affect the

substance of the record. I have particularly considered whether releasing the personal information would provide any additional benefit in this regard. I have weighed this against the right of individuals to have their personal information remain private and have found that there is a clear prerogative for this information to remain private.

Right of Appeal

Should you wish to appeal this decision, you may do so in writing to the Freedom of Information Unit, Department of Foreign Affairs and Trade, 76-78 Harcourt Street, Dublin 2 or by email to foi@dfa.ie. A fee applies for an appeal for access to non-personal information; the level of this fee has been set at €30. For methods of payment, please contact FOI Unit at foi@dfa.ie, or 01-4082857.

You should make your appeal within 4 weeks (20 working days) from the date of this notification. However, the making of a late appeal may be permitted in appropriate circumstances. The appeal will involve a complete reconsideration of the matter by a more senior member of the staff of this Department.
