Dear Mr Foxe

I refer to the request which you have made under the Freedom of Information Act 2014 for copies of any emails, reports, memos and so on since 1 January 2015 relating to the decision to end the Certificate of Irish Heritage scheme.

As you are aware the Certificate of Irish Heritage was introduced in 2011 to recognise descendants of previous generations of Irish citizens in an official way and give greater practical expression to the sense of Irish identity felt by many around the world.

Rather than administering the system itself, it was decided that the Department would engage an external company to administer the scheme, on a concession basis, process applications and issue certificates for a fee to applicants. FEXCO was awarded the contract to administer the Certificate of Irish Heritage following a competitive process in 2011.

The uptake of the Certificate of Irish Heritage has been considerably less than anticipated. From its launch in 2011 until 6 August 2015, 2925 certificates were purchased.

In line with the provisions of the contract, FEXCO notified the Department in June this year of its intention to terminate the agreement with effect from 3 September 2015. Since then the Department and FEXCO have worked closely on the logistics associated with the termination of the agreement.

Arrangements are being considered by the Department to allow the presentation of Certificates of Irish Heritage to continue. The Department is also conducting further analysis on how members of the Irish Diaspora seek to assert their identity. This analysis will inform any future decisions on initiatives in this area.


I have identified 20 records that fall within the scope of your request. I have made a decision to grant full access to 13 records, part grant 6 records, and refuse 1 record. The records are listed in the schedule attached.

Right of Appeal
